FIRM MEMBERSHIP Qualifications: Individual, partnership or corporation directly and lawfully engaged in the practice of funeral directing in the state of Missouri and holding a license to practice said profession that is licensed as an establishment in the state. (This membership is for the established firm's membership.) Membership in this category is entitled to **one** designated voting representative from same establishment (i.e. usually a firm owner or manager). One vote per Firm exercised by the representative. **Also included in a Firm Membership are Branches, Satellites and active licensed Employees.** Firm Members receive one copy of The Missouri Funeral Director but may purchase additional copies.

INDIVIDUAL VOTING MEMBERSHIP Qualifications: Individuals must be licensed and actively engaged in the practice of funeral directing or embalming and **employed by a funeral establishment that is a current Firm Member.** One vote at all meetings of the association.

INDIVIDUAL ASSOCIATE MEMBERSHIP Qualifications: Available to any licensed funeral director or embalmer who is not employed by a Firm or Branch Member, or any non-licensed individual who is employed by a Firm Member. No voting rights for this class.

STUDENT MEMBERSHIP Qualifications: Any student attending a mortuary school and registered with the State Board of Embalmers and Funeral Directors or a person performing an apprenticeship, but not yet licensed. No voting rights for this class.

NON-RESIDENT MEMBERSHIP Qualifications: Individual engaged in the practice of funeral directing or embalming from a state other than Missouri. No voting rights for this class.

RETIRED MEMBERSHIP Qualifications: Any retired licensee, as defined by the State Board of Embalmers and Funeral Directors. No voting rights for this class.

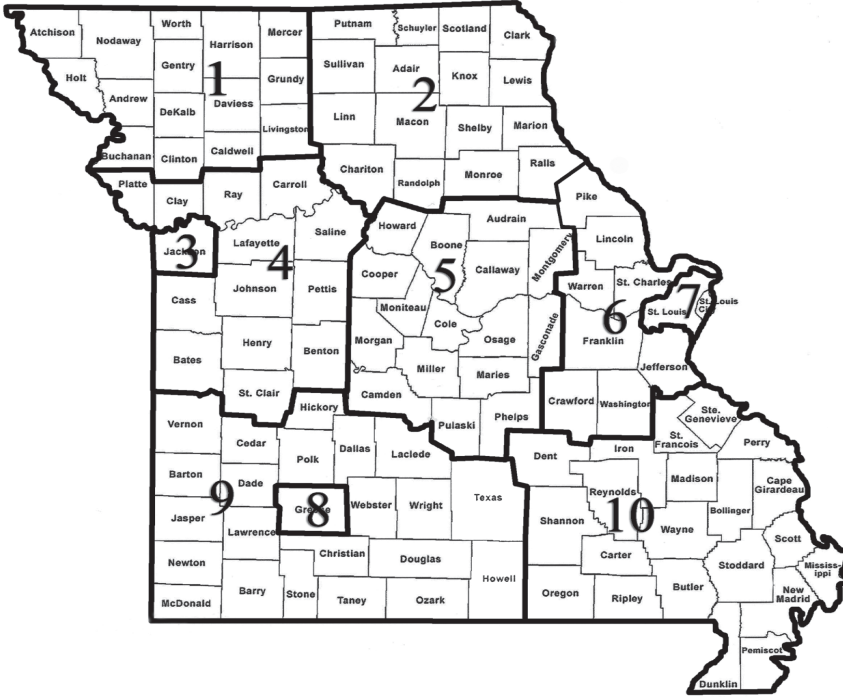
