FIRM TRADE Qualifications: Available to any corporation, firm, partnership or association that does business that is directly connected to the profession of funeral directing and embalming including, but not limited to, supplies, insurance companies, cemeteries, and third party pre-need sellers. The trade firm/company may designate one representative that has benefits of an Individual Trade Member. Not eligible for voting privileges or to serve as officers of the association or its districts.

INDIVIDUAL TRADE Qualifications: Any person who is not actively engaged in the practice of funeral directing or embalming, but who is employed by a Firm Trade Member. No voting rights for this class.
